Notice is hereby given that at 7:00 p.m. on Monday, November 13, 2017, a Public Hearing will be held pursuant to Wisconsin State Statute 65.90 (3) (a), on the Proposed CY 2018 Budget for the Town of Winchester, County of Winnebago. The Public Hearing will be held at the Winchester Town Hall, located at 8522 Parkway Lane, Larsen, WI 54947. The proposed budget detail may be examined at the Town Office during normal office hours or by appointment.

Notice is hereby given that on Monday, November 13, 2017, immediately following completion of the Public Hearing on the Proposed CY 2018 Budget, a Special Town Electors Meeting will be held pursuant to Wisconsin Statute 60.12(1) (c) for the following purpose(s):

1. To consider the adoption of a Resolution endorsing Town Board Resolution 2017-04, A Resolution to Exceed the 2017 Levy Limit, which proposes that the Town levy exceed the state allowable levy limit under s. 66.0602 of Wis. Statutes, specifically, a proposed tax levy which would exceed the allowable Town tax levy for 2017 by 55.555 percent which would be a dollar increase of \$100,000.00: \$80,000.00 for town road and highway expenditures and \$20,000.00 for the Town of Winchester Fire Department/EMS, for a total town tax levy of \$306,560.00 which includes debt service of \$26,560.00.
2. To approve the 2017 total Town tax levy payable in 2017/18, pursuant to 60.10(1)(a) of Wis. Statutes.

A Regular Town Board meeting to approve the 2017 Levy and the Town of Winchester CY 2018 General Fund Budget will be held on Monday, November 20, 2017 at 7:00 p.m. at the Winchester Town Hall.
